1. HOW TO ENTER

- a. These rules govern the 96.5 KOIT PIXAR PIER-DISNEYLAND RESORT FLYAWAY("Contest"), which is being conducted by KOIT ("Station"). The Contest begins on MONDAY, JUNE 25, 2018 and ends on FRIDAY, JULY 20, 2018 ("Contest Dates"). Entrants may enter via online only.
- b. To enter the Contest, entrant may enter online beginning on MONDAY, JUNE 25, 2018 at 12:00AM PST and ending on FRIDAY, JULY 20, 2018 at 11:59PM PST ("Entry Period") as follows:
- c. c. Instagram Contests: To enter, log in to your existing account, or to sign up for a free account, with the social media network site Instagram, (1) post an eligible photo as instructed by Station on Instagram, subject to compliance with the photo requirements in Section 11(h)(ii) below, and (2) include the unique hashtag for the Contest, as designated and announced by the Station. Posts that include any hashtag other than the designated hashtag, and/or posts that do include the designated hashtag for the Contest, will not be accepted for Contest entry.

- d. i. In the event of a dispute regarding the identity of an Online, Social Media, Text, or App Contest Entrant, the Entrant will be the one (1) individual who can demonstrate control over the means by which the Entry was submitted to the Station, as applicable: (i) by logging into an applicable Listener Club, Facebook,

Twitter, and/or Instagram account with the correct user name and password; or (ii) by evidencing ownership of the phone and/or phone number either from which the Entrant's text entry was sent or on which the App is installed and registered to such Entrant.

- e. ii. For any Contest specifically requiring for Entrants to submit a photograph as part of the entry process, the terms "Photograph", "Photo", and/or "Image" may be used interchangeably, and may include, but will not be limited to the inclusion of, any image that may be produced by an analog or digital camera, an optical image scanner (or simply, "scanner"), a "screen dump," "screen capture," "screenshot," or "screengrab," and/or the digital manipulation of one or multiple photographs achieved by the use of image editing software. Photo must be uploaded in either the ".jpeg" or ".jpg" file format (no other formats will be accepted). ONLY THE ENTRANT MAY BE VISIBLE IN THE PHOTO. NO OTHER PERSON MAY BE DEPICTED IN SUCH PHOTO no matter how far away or obscure; provided, however, that Station reserves the right to accept Photos that have parts of other people visible that Station deems at its sole discretion is not material to the Photo and such persons are completely indistinguishable (e.g., a leg or finger). Further Station's decision in this matter is final and not appealable and Station is not obligated to treat every Photo identically (e.g., Station may decide that in one photo a leg is not material, but that a leg is in another photo). Any Photo with any other person(s) depicted in it will be ineligible and disqualified, except as otherwise permitted in this subsection.
- f. iii. For any Contest specifically requiring for Entrants to submit a video as part of Entry process, ONLY THE ENTRANT MAY BE CAPTURED IN THE VIDEO. NO OTHER PERSON'S IMAGE, VOICE OR TALENT CAN BE CAPTURED IN THE VIDEO (no matter how far away, obscure, or otherwise). Any video with any other person(s) or more than one person captured in it will be ineligible, and will be disqualified. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.
- g. Only one (1) entry per person is permitted. There will be up to a total of ONE (1) winner(s) selected in the Contest.
- h. All online entries must be received by the end of the Entry Period.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of CA eighteen (18) years of age or older, and who reside in one of the Greater San

Francisco / Bay Area (San Francisco, Santa Clara, Alameda, Contra Costa, Marin, San Mateo, Solano, Napa, and Sonoma Counties. Void where prohibited or restricted by law.

- b. The following individuals are NOT eligible to enter Station contests, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. Unless the Station otherwise specifies, in its own discretion, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Radio Stations are subject to the following restrictions: Persons who have won a prize valued up to \$100 in the last thirty (30) days are not eligible to participate. BALL RD, ANAHEIM, CA 92803, which includes: up to four (4) Disneyland Resort Three (3) Day Park [Hopper](#) Tickets (must be used by August 15, 2018), coach roundtrip airfare for up to four (4) people on Alaska Airlines departing on August 12 from a Bay Area airport closest to the winners residence into Orange County on Sunday, August 12, 2018 and departing Orange County back to the Bay Area on August 14, 2018 (flights must go in and out of same airport). Flights are chosen by Disney. and one (1) room for up to four (4) people maximum at a Disneyland Resort hotel at Disney's selection for two (2) nights at the Disneyland Resort, checking in on Sunday, August 12, 2018 and checking out on Tuesday, August 14, 2018. Winners must be available to travel August 12, 2018 through August 14, 2018. If winner cannot travel on August 12, 2018 and August 14, 2018, winner must forfeit trip and another winner will be selected. The Approximate Retail Value ("ARV") of the prize(s) is \$2,788.00. Transportation costs are included. Ground transportation included to the resort. in the given price. The winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). Tickets are valid only on the date(s) printed on the tickets, and they are not refundable or transferable, may not be sold to a third party, and may not be substituted or exchanged for cash or credit at any time, nor will they be replaced if lost or stolen. The Station, in its sole discretion, reserves the right to deny entry to or to remove the winner(s) and/or guest(s) if either engages in disruptive behavior or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize related event(s). The Station is not responsible for replacing tickets in the event of show cancellations as a result of weather, promoter, or performer actions. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the

administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station/judges are final.

- c. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.**

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Contest are final.
- b. One (1) prize winner(s) will be selected in the Contest during the following periods of time (“Drawing Periods”)
 - One (1) prize winner will be selected on MONDAY, JULY 23, 2018 at approximately 10:00AM PST in a random drawing of all eligible online entries received between 12:00AM PST ON MONDAY, JUNE 25, 2018 and 11:59PM PST PN FRIDAY, JULY 20, 2018.
- c. Odds of winning depend upon the number of eligible online entries received.
- d. Entries are specific to each designated Drawing Period and will not be included in subsequent drawings.
- e. One (1) winner will be randomly selected by our online system and contacted immediately after being selected. In the event of a tie for a prize, the tie breaker will be determined from among all tied potential winner(s) by the Contest Sponsor. The Contest Sponsor, at its sole discretion, shall make the final decision to resolve any tie.
- f. Winners must listen to the Station to win but do not need to be present to win. In such cases, there is no purchase necessary to enter or win, except for reasonable postage and handling fees the amount of which shall not exceed \$1.50 plus the actual cost of postage to ship the prize.
- g. Potential winner(s) will be notified of winning by telephone at the time of the drawing. Prize(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases. The Station's or its Contest Administrator's computer or telephone system is the official time keeping device for this Contest. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good-faith determination that an entrant has cheated or committed fraudulent activity in connection with a Contest, the Station may disqualify that entrant from entering and/or winning this and any or all future Station-administered contests and seek damages to the fullest extent permitted by law.
- b. If due to circumstances beyond the control of the Station, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but does not have the obligation, to cancel, terminate, suspend, or modify the Contest and shall not be required to award a substitute prize(s). If any provision of these Official Rules is irrevocably inconsistent with any provision set forth on the Contest webpage, then the provision of these Official Rules will prevail but solely to the extent of the inconsistency.
- c. Calling the Station regarding the Contest constitutes permission for the Station to tape the caller's voice and use it on the air. All telephone calls during the Contest may be taped without further permission from the caller.  - d. Each winner will be required to produce identification satisfactory to the Station.
